The Ven Dr David Jenkins, National Chaplain writes...

Dear Friends

Words matter. They signal where we come from and where we belong. I come from a culture where language is colourful, descriptive, and almost impossible for a non-native to understand. So, my family dry their clothes in an airing cupboard whereas I use the hot press!

Words also matter in church. They can signify much about what we believe and how we think about our faith and our relationship with God. For example.....do we say Lord's Supper or eucharist or Mass or Holy communion. These speak to what we might call church tradition, but they also communicate something of what we believe spiritually and how we practice our faith.

I start here because I am writing this letter to you on the Feast of the Presentation, which rejoices in not just one but four different titles! The Feast of the Presentation of Christ in the Temple or The Feast of the Meeting of the Lord or The Feast of the Purification of the Blessed Virgin Mary or the much more Anglican Candlemas is among the most ancient feasts of the Church and is the most ancient of all the festivals in honour of the Virgin Mary; each title potentially revealing a different aspect of the history and meaning of the feast.

The feast is also a good example of an occasion where Christian doctrine and tradition meets folklore and popular superstition to create an intriguing synthesis which only serves to enrich the mix for Candlemas is also important within the secular and pagan calendars. This day is the traditional day to remove the cattle from the hay meadows and from the field that is to be ploughed and sown in the coming spring. In other parts of the world, contemporary celebrations at the Presentation have also been influenced by pre-Christian customs, such as the spreading of ashes by farmers in their fields on this day each year to ensure a better harvest, and keeping ashes on the roof of a house to keep evil spirits away. And before you get too superior about all these superstitious practices in other 'less civilised' places, and succumb to some Anglican conceit, in this country Candlemas has long been connected with many popular sayings concerning weatherlore. It is popularly held that if the day's weather is good, then we shall have more cold and wintry weather before the Spring finally arrives.

But what does this Feast mean for us today? We are the inheritors of this heady mix of pagan and Christian symbolism and belief; how do we make sense of it all? What today can we present to the Lord as we stand or kneel before Him? The penitential season of Advent and the self-inflicted self-righteousness of New

Year resolutions have given us plenty of opportunity for us to look at ourselves in the spiritual mirror. So, in what condition do we present ourselves to Christ? What sacrifices did we make during Advent? Have we begun cultivating a new virtue? Have we attempted to give up an old vice? Have we said our prayers? Have we set a Christian example to our neighbours? Have we thanked God for all that we have received? What has changed in our way of life since we celebrated the Birth of Christ forty days ago? Lots of difficult questions with even more challenging answers!

I suspect that for most of us the answers to these reflections will be underwhelming if not downright depressing. Yet if the feast is about anything it is about encounter and in particular about the encounter each of us may have with our Christ and saviour. Simeon and Anna had waited a lifetime to encounter the Christ and as soon as they set eyes upon this tiny child they knew. They knew and recognised him for what he was; the son of God. For us perhaps the light sometimes burns a little less brightly and we fail to recognise our moment of encounter. One of the roles of a verger is to facilitate that encounter by providing a safe and holy space in which such a moment might take place. Many of us I think stumble around failing to hear the call but if the church is truly to be the body of Christ here on earth then each and everyone one of us needs to have that encounter or at least be open to the reality, not the possibility but the reality, that Christ waits to meet all of us just as he did that day over 2000 years ago when he came into the lives of Simeon and Anna. So, if Christ is ready to meet us; are we ready to meet Him?

From the Executive Committee Way Forward - Branches becoming Groups

n January the Executive Committee met to discuss how to pave the way forward for changes that are urgently needed to keep the Guild in existence for years to come.

We were very aware that any change for is scary, and there is often the adage of 'if it ain't broke, don't fix it'. For some Branches this is good, and we are not requiring any change, but for some Branches where Officers have wanted to step down, after giving of many years to their Branch and the Guild, but no one is able to step up—meaning that the old Officers remain and remain, there is a want for a better system. Below is what was agreed by the Executive on how to move forward.

The Executive want to thank those Branch Officers for their time and gifts that they bring to the role and to acknowledge the tireless way they continue to promote the aims of the Guild, Thank you. Secondly, we accept that we as Members have busy lives, often juggling a busy work life and family life, where sometimes additional commitments to the Guild cannot be taken without something else having to give, much to the detriment of your own personal life.

To answer some worries for Branches, and to look into other aspects, the Executive set up a working group called 'The Way Ahead Group', seeking some answers to these questions of Branch Management in today's society and to look at other aspects, such as Training, Succession Planning etc.

One of the solutions that has been worked on is the formation of Groups, rather than Branches, where no longer are 3 Branch Officers needed to be found, only one Group Contact. No longer would there be the need for Formal Branch Meetings where only a small number of Members are able to attend owing to the distance that members sometimes need to travel, late at night, which can be disheartening for the person organising the event.

Over the last number of decades smaller Branches have been forced to amalgamate with neighbouring Branches that can sometime mean that a person may have to drive over 90 minutes in one direction to meet with others. Groups can now be formed from the larger areas and where Branches have closed in the past.

The Executive Committee has met and approved an update of the Statutes (these are now on the website) that now shows how Groups may be formed and organised. How the subscription would be paid, going forward. The new section of the Statutes to note is section 2 and the changes to 1.14 and 10.

What this means to you as a Branch:

- At your AGM or at an EGM called for this allow a discussion to be held on the matter
- Should your Branch decide, by vote, to become a Group to decide who the single Contact will be?
- To formally vote to close the Branch and follow the rules of transferring the finances of the Branch to the National Treasurer.
- To pay this year's current subscription, as normal, but next year all will be paid by members centrally.
- A reminder that Branch Life Membership would cease to be, for Branches that have closed, on the beginning of the following Financial Year. The Members would be asked to pay the standard Membership Fee moving forward.
- One concern that was raised, was what happens with the funds that the Branch holds and if it would be lost, the agreement was that while the National Treasurer would hold the Branches funds (ring fenced) the Group, formed in the stead of the Branch, would be able to draw upon the funds – with proper receipts – for legitimate expenses of the Group.

Branches that do not wish to adopt this method, are invited to continue as is, with subscription being collected by your Branch Treasurer and National Membership being paid, by the Branch, to the National Treasurer.

We do ask that you take time to discuss this in your Branches, and please do reach out to us with any questions so that when you discuss this you are armed with as much information as you can possibly have.





As we step into AGM season, a reminder to all branches that Annual General Meetings must be held **by 31 March 2025**. This is a crucial time for reflection, planning, and ensuring the continued strength of our Guild at every level.

To keep everything running smoothly, please ensure the following:

- Annual Returns These must be sent to your Regional Representative, the National Treasurer, and the General Secretary.
- Capitation Fees These should be sent directly to the National Treasurer.
- Membership Records A full set of current membership details (including addresses, emails, and phone numbers) must be sent to the General Secretary.

By meeting these requirements on time, we uphold the integrity of our Guild and ensure that all branches remain well-connected and fully engaged in our shared mission.

St Albans Branch, Janny Huskison writes...

uring the second half of our year of events we had the aim of visiting a range of places within our diocese.

Visit to St Andrew's Bedford

Despite the heavy rainfall, members travelled from Heath and Reach, Potters Bar and Leighton Buzzard on 21st September to enjoy a most interesting tour of St Andrew's, Bedford, where we were welcomed by the Vergers, Gareth Burrows and Alan Colley. Our members from St Andrew's gave us a very informative talk about the origins of St Andrew's dating back to the colonial days of the Indian Raj, when families returned from India, often to educate their children at the schools around Bedford.

The Tin Tabernacle of 1895 was replaced by the Early

English style nave between 1920 and 1930, with the bell tower and chapel being added in the 1960s and a new Church Centre in the early 2000s. There is interest for embroiderers, musicians and bell ringers at St Andrews. We viewed a full set of altar frontals, designed by Joan Freeman and embroidered by the St Andrew's Guild of Embroidery in the late 1960s and early 1970s. This is said to be one of the few – if not only – full set of embroidered altar frontals and vestments made by the parishioners themselves. The Harrison and Harrison organ was installed in 2015. Six bells from the redundant church of St Mary's date from 1594 to 1748 and there are the two treble bells which were cast in 1982.

We were all impressed by the facilities available, and the wide

range of activities that go on at the church each week. We were also treated to a delicious afternoon tea. Luckily we all returned to our homes safely, because by the following day the road we had used ,the A412 was 6-8 feet under water.

Trip to St Albans Abbey

Our recent visit to St Albans Abbey took place in October. We were given a most interesting talk on some of the altar frontals and copes, which were brought out for us to gain a closer inspection, including that of the Dean. This had the most incredible embroidered depiction of the story of St Alban. Do look for the single daffodil on the beautiful covering of the shrine of St Amphibalus. Our visit was rounded off by attending the mid day mass at St Alban's shrine and lunch in the café.

Our year was rounded off by our visit to All Saints, Leighton Buzzard for our Christmas lunch, which was enjoyed by all.

e were invited to visit Bradford Cathedral in February by Head Verger Sam Fletcher.

Before entering the building we took the time to walk along the story boards outside. Starting at 600AD and ending at modern day. It gives a fascinating snap shot of the Cathedral's history. On entering we were struck by the simplistic elegant design with lots of quiet spaces to sit, pray and reflect.

Libby's day off



The Nave, completed in 1485, has undergone many changes of the centuries.

Above our heads the roof is lined with wonderful painted wooden Angels which

are said to have links with Kirkstall Abby.

The Tower, completed in 1508. It was bombarded by the army of Charles 1 in 1642/3.

It stands 100 feet tall and houses 12 bells.

The West window depicts women in the Bible and there is an interesting list of Vicars/Incumbents dating back to C13th

The Font is made of Caen stone which is creamy coloured Jurassic limestone found in France and has a Tudor wooden canopy circa 1536.

The Lady chapel is at the heart of the Cathedral's daily ministry. On the West side there is one of the earliest commissions of Stained glass carried out by William Morris and Ford Madox Brown. It is back lit to show of the wonderful design and colours. The bottom panel showing the Pelican pecking at his own heart. A Christian symbol used in several other Pre Raphaelite designs. The high altar frontal is a tapestry frontal made by the Morris Co.



There are lots of things to see here, beautifully carved pews and regular exhibitions. While we were here there was a young people's exhibition called Beacon of Hope.

In March there is a William Morris Stained glass tour.

We visited in Feb, but there is a full summer season of events.

Including the Patronal fest July 2nd, Literary Fest July 8th, evening concerts, visiting choirs and free lunch time organ recitals. Entry to the Cathedral is free. Donations welcome.
